**All pets shall be treated for parasites,
such as fleas, upon entrance to the Kennel at owner's expense.**

This contract is between Animal House (herein called "the Kennel")
and the pet's Owner, whose signature appears below:

1. Owner agrees to pay the rate for boarding in effect on the date of pick up.
2. On the day of pick up the pet must be picked up by 1:00 p.m. to avoid another days charge.
3. It is MANDATORY that all pets MUST be vaccinated for animal diseases such as rabies, distemper, parvovirus (DHL P.P.), corona and bordetella within the time period veterinarian recommended prior to the pet entering the Kennel.
4. Owner agrees to pay all costs and charges for special services requested and all veterinary costs for pet during it's stay.
5. Owner agrees that the pet shall not leave the Kennel until all charges are paid.
6. By signing this contract and leaving pet with the Kennel, Owner guarantees the accuracy of all information given.
7. Kennel shall exercise reasonable care for pet. It's expressly agreed by the Owner and the Kennel, that the Kennel's liability shall in event exceed the lessor of the current charter value of a pet of the same species or the sum of \$200.00 per animal boarded.
8. Owner agrees to be responsible for any and all acts of behavior of the pet, during it's stay in the Kennel, any damages by pet will be paid by pet Owner.
9. Owner specifically represents that he or she is the sole owner of pet.
10. The Kennel shall have and is granted a lien on said pet for any and all charges resulting form boarding pet. The Owner agrees that in the event the boarding charges are not paid when due in accordance with the contract, the Kennel may exercise it's legal right to hold pet for 10 days while awaiting payment, after which pet is placed for public sale for sufficient money to cover the charges incurred for said pet's stay. If pet is sold for an insufficient amount to cover charges incurred, the Kennel will seek legal action against the pet Owner.
11. If pet becomes ill during stay and needs professional attention, the Kennel may engage the services of a Veterinarian at Owner's expense along with a \$20.00 transportation fee.
12. It is required that pets receive the Bordetella Vaccine every 6 months. The Bordetella Vaccine aids in the prevention of certain strains of the Bordetella Virus, better known as "Kennel Cough". However, the kennel is not responsible for transmission of "Kennel Cough".
13. Animal House is not responsible for your pet acquiring diseases while staying in the Kennel, or any costs associated with treatment of such illness. Please vaccinate your pet properly.

The Kennel guarantees the best care for any pet that it could possibly give. The Owners of this Kennel have pets and will treat your pet just as they would treat their own. We appreciate your business and hope to serve you and your pet now and in the future.
